A Pickering Middle School Building Committee Meeting was held to review the status of the project. A quorum of the School Building Committee was present. J. Cerulli, SBC Chair, called the meeting to order at 2:32 PM.

I. Approval of February 25, 2016 Meeting Minutes

1. The following motion and vote was taken:

MOTION: C. Latham moved, seconded by E. Calnan, that the School Building Committee approve the February 25, 2016 Meeting Minutes.

II. Introduction of Selected Designer – Raymond Design Associates, Inc.

- 2. The MSBA Designer Selection Panel voted overwhelmingly to select Raymond Design Associates (RDA) as the Designer for the Pickering Middle School. The DSP met on March 22, 2016 and reviewed all four proposals submitted by the Architects and voted. The City received three of the sixteen votes. Given that the votes for RDA were significantly higher than the other three Architects, it was decided that it was not necessary to shortlist three firms for interviews.
- 3. Gene Raymond, Principal, Steve Lamothe, Project Architect and John Bartecchi, Design and Construction Coordinator, were introduced to the SBC.

III. Feasibility Study

General Overview of Feasibility Study Requirements

- MSBA's Module 3 Feasibility Study guidelines were discussed. LeftField will upload Module 3 on the SBC's website.
- 5. There are two parts to the Feasibility Study, the Preliminary Design Program and the Preferred Schematic design Report. These submissions are required to be approved prior to starting the Schematic Design.

Outline for the Preliminary Design Program Submission (Step 1of Feasibility Study)

- LeftField provided an outline of the requirements of the Preliminary Design Program which is first phase of the Feasibility Study. A new Appendix 3A has been added to Module 3 which outlines requirements for documenting the Educational Program and Plan. Leftfield will also upload Appendix 3A to the SBC website.
- 7. The primary focus of the Preliminary Design Program (PDP) is to develop/confirm the Educational Program and available sites that could accommodate the Educational Program. The PDP will inform and provide the background for the Preferred Schematic Report.
- 8. It was recommended that three Sub-Committees be coordinated to for the three primary areas of focus. The following SBC members volunteered for the following Sub-Committees.

9. RDA has an Educational Planner as part of their Design Team. The Educational Planner is David Stephen of New Vista Design. With 15 years of experience as an Architect and School Designer and 25 years of experience as a Secondary School Teacher, Assistant Principal, K-12 Curriculum Developer and Teacher Trainer, David Stephen is well versed in both design and education. LeftField circulated a pamphlet about New Vista Design.

10. New Vista will conduct two Educational Visioning Sessions to discuss the possibilities of ways to integrate the educational program and the school building design.

11. Two Educational Visioning Sessions were planned as follows:

- 12. The Educational Program Sub-Committee will report on the educational visioning process and outcomes to the SBC at the next SBC Meeting.
- 13. LeftField gave an overview of the potential options for the building design. The Design team will need to review the following six design options as required by the MSBA:
 - o Repair and renovation of the existing building
 - o Construction of a new building with a design enrollment of no more than 1,660 students
 - Construction of two middle schools with both projects accommodating a total of no more than
 1,660 students
 - o Construction of a new middle school and an addition to the existing Breed Middle School with both projects accommodating a total of no more than 1,660 students
 - Addition and renovation to the existing building to accommodate a total of no more than 1,660 students
 - o Renovation to the existing building and construction of another middle school with both projects accommodating no more than 1,660 students
- 14. RDA reviewed a map of the City and discussed 9 potential sites to be analyzed for suitability. It was noted that not as many student are in the Pickering MS district. The most populated student district is the Breed MS district.
- 15. A meeting was schedule for the first Site Selection Sub-Committee on April 11, 2016 at 10:00 AM.
- 16. Design Sub-Committee Meeting s will be scheduled at the next SBC meeting.
- 17. LeftField will send out meeting notifications for all Sub-Committee Meetings.

IV. Schedule Update

- 18. LeftField will update the Project Schedule to include the dates noted above for the scheduled meetings.
- 19. The Preliminary Design Program Submission is scheduled to be submitted to the MSBA on June 10, 2016.
- 20. A Public Forum was scheduled for May 18, 2016 at 7:00 PM in the Pickering MS Auditorium. The Forum will update the Community on the status of the project and the developments of the Educational Program and the site options available. Public comments will be taken.
- 21. LeftField will bring a draft of a flyer for public notification of the Public Forum to the next SBC Meeting.

V. Budget Update

- 22. The Project Budget was reviewed which included expenditures to date.
- 23. LeftField provided the Designer Contract to Raymond Design Associates to include their M/WBE participation and their hourly rates and for signature so that the City can execute the contract.

VI. Other Business/Discussions

24. One of RDA's MSBA required Consultants is a Security Consultant. RDA will be looking to schedule a meeting with the City's Security Consultant, School, Fire and Police to discuss the security plan so that the plan can be confirmed and documented in the Preliminary Design Program.

25. M. Donovan provided a CD of the land survey of the Parkland Avenue site. Leftfield will copy and return CD to M. Donovan.

VII. Next Meeting

26. The next PMSBC meeting will be scheduled for April 21, 2016 at 2:30 PM in Room 107. LeftField will send out the meeting notice once a room is confirmed.
